1.My dog can walk around on a hands-free lead with 100% loose lead walking for 20 minutes on a street.	
2. My dog can perform an emergency stop running at least 20m away from their handler. This should be done off lead in a park.	
3. My dog can perform an emergency stop running towards me from at least 20m away. This should be done off lead in a park.	
4. My dog can demonstrate curb savviness.	
The assessor will hook a light line to your dog, you will walk towards the curb and drop your lead. The dog must not follow you into the road without you cueing them. The line is held by the assessor to prevent this.

1. My dog can voluntarily wear a correctly fitted muzzle and walk for 30 seconds without distress.	
2. My dog can open their mouth on cue to be inspected.	
3. My dog can position themselves for a fake blood draw without restraint (neck).	
4. My dog can show that they will allow the inbetween of their paws to be checked, and will offer them voluntarily.	
5. My dog will show their belly for inspection	
6. I can demonstrate my dogs grooming routine.	
7. I can give 10 signs that a dog might need veterinary attention.	





1.My dog can walk on a loose lead for 30 minutes in a moderately busy shopping retail park.	
2. My dog can navigate an entire circuit of a shopping centre off lead or just on a dormant pull strap/traffic handle. If the handler is unable to do this, they may nominate someone else to do so.	
3. My dog can hold a 2 minute stay from 10 steps away with moderate free flowing distractions natural to the setting.	
4. My dog can settle for 30 minutes whilst the dog and handler team have a light bite to eat. If needed, the handler may get up during this time but the dog must remain settled.	
5. My dog and I are able to walk 50 metres with a dormant attachment or off lead whilst approached by another dog/handler team 3x. On one of these occasions, the team under assessment must leave their dog from 10 metres away to tell the other handler something, and return to their dog without them breaking position.	



6. My dog has been tested against the following noises: Fire alarm Checkout beeps Large trolleys within 1m distance Loudspeaker announcements A loud object being dropped next to, to the side of, in front or behind the dog Sirens 7. My dog can remain settled whilst a light object is dropped on them (e.g. small soft toy). 8. A 100% score is required to pass the test.

Handlers CANNOT lure for any of the exercises, but are encouraged to heavily reward after each exercise. Handlers must reward from a place that isn't on their person, and must be hidden from their line of sight at all times.





1.The handler must show they possess a first aid kit that is easily accessible for their dog in an emergency and prove the emergency vets number is saved in their phone.	
2. The dog must show that they are able to settle quietly whilst the handler eats a meal for 30 minutes.	
3. The handler must be able to show their dog can appropriately behave and ignore visitors should an emergency occur. This includes the dog being boundary trained to the front door for safety for 2 minutes. The handler must be able to show that (but may use a loose training line) their dog can respect the front door boundary even when people are wandering in and out the house with the front door open.	
4. The handler must be able to describe how they make fireworks night a stress free experience for their dog.	



The handler must be able to demonstrate what preparations they have made for their dog in the event of:

- A fire
- A road traffic accident involving a vehicle they are travelling in
- A period of mild illness if someone was unable to help you
- If you were injured on a walk
- · If your dog was injured on a walk
- If you had a hospital stay
- · Severe cold weather
- · Severe hot weather
- Flooding (if appropriate)



5. The dog must be able to ignore another dog playing off-lead next to them around 2 metres away.	
6. The dog must be able to ignore a scrap of high value food chucked to the dog whilst loose lead walking, and in static position.	
7. The dog must be able to cope with a pet dog rushing up to them, but that dog will make light physical contact (non determined sniffing). This should be done in a pet friendly place.	
8. The dog must be able to be held by someone else for 6 minutes whilst the handler is at least 60 metres away.	
9. The dog must be able to demonstrate that they can sit, get in a car, be safely restrained, drive for 20 minutes without signs of stress, control release, prepare and wait for release of unloading, and return to the handler's side in a controlled and safe way.	



10. My dog can do the following:

- Have a contextual cue to keep automatically under control on a trail (e.g. see dog, return to handler, see person, return to handler). This needs to be tested at peak time.
- Able to walk down a canal and pass at least 10 distractions on a loose lead, 2 of which must be dogs.
- Able to respond appropriately to seeing a reactive dog (an instructor will ask their dog to speak on cue to avoid unethically triggering someone elses dog on purpose). The dog must be less than 5m away.
- Able to respond appropriately to seeing someone playing a sport, off lead.
- Able to respond appropriately if they saw someone who was obviously frail, off lead.
- Able to respond appropriately to a child scared of dogs, off lead.
- Able to respond appropriately to walking around birds, off lead.
- Able to respond appropriately walking round squirrels, off lead.
- Able to respond appropriately walking past a cat at a 5m distance
- Able to respond appropriately to a drunk person, off lead.
- Able to deal with and ignore a pet dog trying to initiate play in a public park.





- 1. You only have 5 minutes to walk your dog in an area that is small and your dog must be kept on lead. You are travelling by train and it is critical your dog is calm: How are you going to wear them out?
- 2. You are having to have an emergency hospital stay and no one can get to you for a couple of hours to feed your dog. How are you going to work around this situation?
- 3. You are out on a walk and you realise your poo bags have blown away in the wind. Your dog chooses that moment to have a poop. What are you going to do?
- 4. You notice there is an ongoing police incident in public access. The dog team have turned up. Their dogs are barking at your dog. What are you going to do?
- 5. The only way out of a train station seems to be an escalator. How are you going to navigate this situation?
- 6. There is a child that is obviously scared of dogs in a shop. Her mum looks embarrassed. You still need to pay at the checkout. What are you going to do?



- 7. You notice there is another assistance dog team, but their dog seems to be poorly behaved. What are you going to do?
- 8. You are out in public, when you notice two other teams. One seems unaware the other is filming them. What would you do?
- 9. You notice there is a guide dog team very nearby. What could you do to help the handler if you have to pass?
- 10. A drunk person keeps harassing you to pet your assistance dog. You have told them no three times and they still aren't listening. What could you do to keep yourselves safe?

 - The dog must then be left for 1 minute out of sight in a busy environment.

- This must be done both indoors and outdoors.
- The handler may nominate an additional spotter for security and this must be done with safety in mind.

4. The dog must be able to settle for 1hr minutes whilst the dog and handler team have a substantial meal. If needed, the handler may get up during this time but the dog must remain settled. The handler may not use chews or kongs, but are encouraged to use settle mats if appropriate and allow free access to water.





5. The dog and handler team must be able to walk 20 metres with a dormant attachment or off lead whilst approached by another dog/handler team with an "out of control" off lead dog. To test this, we will expect your dog to stay focused even with a dog being constantly called past your dog x 3.	
6. The dog needs to be tested against at least 4 of the follownsettings:	wing

29. The partnership must be able to demonstrate the dog can appropriately interact with at least 10 different novelty objects.	
30. The partnership must show that they can safely work around all of the following (if present):	
 Other people (different ages, heights, ethnicities, clothing types, hi viz, volume, movement types) Other animals (pet dogs, assistance dogs, assistance cats, small animals, wild animals, birds etc) 	

Please note: A 100% score is required to pass the test.

Any aversive handling or equipment will result in immediate disqualification.

Any soiling in public access will also result in disqualification. No aggressive or reactive behaviour is allowed.





The purpose of this test is to assess the suitability of dogs as assistance dogs for Infinity Dogs CIC.

Dogs must be 18 months old or older and have completed 24 or more training hours with Infinity Dogs CIC.

A 100% score is required to pass the test.

Handlers CANNOT lure for any of the exercises, but are encouraged to heavily reward after every second exercise. Handlers must reward from a place that isn't on their person, and must be hidden from their line of sight at all times.





1. The handler must show they possess a first aid kit that	
is easily accessible for their dog in an emergency and	
prove the emergency vets number is saved in their	
phone. They must show BOTH VERSIONS are clearly	
labelled. They must also have a portable version and a	
spare phone charger.	

- 2. The dog must show that they are able to settle quietly whilst the handler eats a meal for 1hr. They must also be able to name at least 5 foods that are toxic to dogs.
- 3. The handler must be able to show their dog can appropriately behave and ignore visitors should an emergency occur. This includes the dog being boundary trained to the front door for safety for 5 minutes. The handler must be able to show that (but may use a loose training line) their dog can respect the front door boundary even when people are wandering in and out the house with the front door open. If they have a front garden they must be able to demonstrate when released they can treat that or the drive as an equivalent boundary, even if the handler crosses the road.



The handler must demonstrate they have a packed go bag for any emergencies for their assistance dog which must contain the following:

- A spare lead and harness
- A spare vest
- A laminated card explaining Assistance Dog law
- Food and water for 72 hours
- Enrichment activities
- Towel
- First aid kit (canine)
- A head torch
- Reflective and/or light up gear (A yellow reflective lead is a must if the team wish to fly)
- Crash tested harness and seat belt attachment
- Copies of any insurance and medical/training documentation
- Copies of any travel documentation
- Treats
- Chews
- Non squeaky toys
- Settle mat/portable bed
- Muzzle
- · Long line
- Spare poo bags
- Wet wipes
- Water bowl
- Food bowl
- Whistle
- Gps tracker/airtag/spare charger (if owned)
- DogLost account



This is to encourage handlers to think ahead and consider a level of emergency preparedness for them and their dog. We would advise keeping a go bag at home, one in a car, and taking as much as you can out day to day to cover any eventuality. This could be because of:

- Floods
- Owner hospitalisations
- Severe weather
- Power cuts
- Emergency evacuations
- Major incidents involving the emergency services that may involve having to leave a particular location for a long time





The following must be done both on lead and off lead or with a dormant attachment:

- The dog must be able to maintain a loose lead and ignore distractions while walking past a group of people talking loudly and laughing.
- The dog must be able to navigate through a crowded park without getting distracted by people playing sports or children running around.
 - The dog must be able to stay focused and ignore a person walking by with a shopping cart, making noise and pushing it close by.
- The dog must be able to walk past a group of people eating at a restaurant patio without trying to approach or beg for food.
 - The dog must be able to remain calm and ignore a person walking by with a baby in a stroller, making baby noises and movements.
- The dog must be able to walk past a group of people sitting on a bench, talking and eating ice cream, without trying to approach or beg for food.
 - The dog must be able to stay focused and ignore a person walking by with a large, colorful umbrella.

- The dog must be able to walk past a group of people listening to loud music without getting distracted or wanting to investigate.
 - The dog must be able to remain calm and ignore a person walking by with a bicycle, ringing the bell and riding close by.
- The dog must be able to walk past a group of people playing a game of catch without getting excited or wanting to join in.
- The dog must be able to stay focused and ignore a person walking by with a bag of popcorn, eating it and dropping some on the ground.
- The dog must be able to walk past a group of people sitting on a park bench, talking and drinking coffee, without trying to approach or beg for attention.
 - The dog must be able to remain calm and ignore a person walking by with a large, inflatable beach ball.
- The dog must be able to walk past a group of people having a picnic, with food spread out on a blanket, without trying to grab any of the food.
 - The dog must be able to stay focused and ignore a person walking by with a skateboard, performing tricks and making noise.





- 1. What would you do if you spotted an ill behaved assistance dog that you genuinely believed that you, your dog or the public were under threat?
- 2. What things might you take into account if your dog has to work in close proximity to a young handler?
- 3. What would you do if you were approached by an unsupervised child wanting to pet your dog?
- 4. What steps could you take to prevent unwanted interactions with the public?
- 5. What steps can you take to make public access less stressful for your assistance dog?
- 6. How would you handle a situation where your assistance dog becomes anxious or stressed in a crowded environment?
- 7. What strategies would you employ to ensure the safety and well-being of your assistance dog in a busy city?



- 8. What precautions would you take to prevent your assistance dog from getting distracted by food or other tempting items in public places?
- 9. How would you handle a situation where someone approaches you and your assistance dog without asking for permission first?
- 10. What steps would you take to ensure that your assistance dog remains focused and attentive during important tasks?
- 11. What measures would you take to ensure that your assistance dog remains calm and composed in high-stress situations?
- 12. How would you handle a situation where someone is allergic to dogs and requests that you keep your assistance dog away from them?
- 13. What steps would you take to ensure that your assistance dog is well-rested and not overworked during long days of assisting you?
- 14. How would you handle a situation where someone is fearful of dogs and expresses discomfort around your assistance dog?
- 15. What strategies would you employ to ensure that your assistance dog remains obedient and well-behaved in public places?
- 16. How would you handle a situation where someone tries to distract or play with your assistance dog while they are working?



- 17. What steps would you take to ensure that your assistance dog is properly groomed and presentable in public settings?
- 18. How would you handle a situation where someone questions the legitimacy of your need for an assistance dog?
- 19. What strategies would you employ to ensure that your assistance dog remains focused and attentive even in noisy environments?
- 20. How would you handle a situation where your assistance dog is approached by another dog that is not well-behaved or aggressive?
- 21. What steps would you take to ensure that your assistance dog is properly hydrated and provided with breaks during long outings?
- 22. How would you handle a situation where someone tries to feed your assistance dog without your permission?
- 23. What strategies would you employ to ensure that your assistance dog remains calm and composed during loud noises or sudden movements?
- 24. How would you handle a situation where someone tries to pet or interact with your assistance dog while they are wearing their "do not pet" vest?
- 25. What steps would you take to ensure that your assistance dog is comfortable and well-adjusted in different types of weather conditions?



- 26. How would you handle a situation where someone tries to take a photo or video of your assistance dog without your consent?
- 27. What strategies would you employ to ensure that your assistance dog remains focused and attentive even in unfamiliar or new environments?
- 28. How would you handle a situation where someone tries to engage in prolonged conversation with you while your assistance dog is working?
- 29. What steps would you take to ensure that your assistance dog is properly exercised and mentally stimulated on a regular basis?
- 30. How would you handle a situation where someone tries to play or roughhouse with your assistance dog inappropriately?
- 31. What strategies would you employ to ensure that your assistance dog remains calm and composed during medical procedures or emergencies?





Must be able to demonstrate that at least 15 skills can be done by another person for medical, grooming or general husbandry, in a public access environment.



1	.The dog must be able to walk around a busy indoor
	venue for 30 minutes off lead or a traffic
	handle/dormant PS.



2. The dog must be able to successfully cope with a visit to a cinema or a threatre. Handlers should take into account spend patterns for their dog and any needs they may have to ensure their dog settles the entire time and is not disruptive.



3. The dog must be able to hold a 5 minute stay from 20 steps away in a busy environment in sight. Someone must attempt to distract the dog by touching or with food twice.



- The dog must then be left for 3 minutes out of sight in a busy environment.
- This must be done both indoors and outdoors.
- The handler may nominate an additional spotter for security and this must be done with safety in mind.

4. The dog must be able to settle for 1hr minutes whilst the dog and handler team have a substantial meal. If needed, the handler may get up during this time but the dog must remain settled. The handler may not use chews or kongs, but are encouraged to use settle mats if appropriate and allow free access to water. The server must make eye contact and try to talk to the dog.

5. The dog and handler team must be able to walk 30 metres with a dormant attachment or off lead whilst approached by another dog/handler team with an "out of control" off lead dog. To test this, we will expect your dog to stay focused even with a dog being constantly called past your dog x 3.	
6. The dog needs to be tested against at least 4 of the follo settings:	wing
 A short supermarket trip (30 minutes) A trip to a bank (15 minutes) A clothes shop (15 minutes) A train journey (45 minutes) An arcade (10 minutes) A museum (15 minutes) + another novel indoor setting of choice + another novel outdoor setting of choice 	
7. The dog must be able to hold a position whilst someone accidentally drops a light object (e.g. a small soft toy) on the dog three times and gently touches	
them. 8. The dog must be able leave high value food thrown next to them whilst walking (less than 10cm away) and static.	
9. The handler needs to be able to carry a hot drink over a distance of 30 metres with their dog off lead/DA.	
INFINATE OF STREET	

10. The dog must be able to walk past and stay for 30 seconds near glass transparent walls without showing distress.	
11. The dog must be able to do a 45 step recall from a stay in a high demand environment.	
12. The dog must have evidence of riding a train journey, and able to navigate between three carriages, leaving their dog in an out of sight stay for 30 seconds in another carriage (spotted) with their dog off lead/DA.	
13. The partnership must have attended at least 3 scenario based training trips for novelty scenarios.	
14. The team must be able to navigate an airport landside off lead or dormant attachment.	
15. The team must be able to show they are able to safely navigate interactions with the emergency services. This includes being held for a passive absence of 30 seconds.	
16. The team should demonstrate they are able to work their dog in the dark when needed, both exercised and street walking.	
17. The team must be able to demonstrate that their dog is able to do at least 5 tasks to help them access day to day life.	
18. The team must be able to demonstrate they are able to work in a library if required, off lead or using DA.	



19. The team must be able to navigate either going in/out a lift or up/down stairs off lead.	
20. The team must demonstrate they are able to work in a major transport hub off lead/DA.	

21. The team should be able to demonstrate they can work in at least 3 of the below settings relevant to the handlers lifestyle and be worked off lead or DA.

- A theatre
- A cinema (normal viewing)
- A theme park
- A wildlife park
- A gym
- A swimming pool
- A museum
- A long trail
- A bowling alley
- A tennis court
- A skate park
- A comedy club
- A dance studio
- A farm
- A carnival
- A outdoor market
- A fun fair
- A busy pub.



22. The dog should display traffic savviness and refuse to step into the road if oncoming traffic is approaching.	
23. The team should be able to show how they are able to navigate automatic and revolving doors off lead or on a DA.	
24. The dog and handler team should be able to demonstrate how they are able to do at least 3 of the following:	
 Operate an emergency pull cord Navigate stairs politely with handler Navigate stairs with secondary handler Navigate an escalator Navigate a lift 	
 25. The dog must show how they navigate a tight space with another team OFF LEAD/DA. This must include: 3 "surprise" encounters by another dog Walking past less than 50cm away Walking head on twice Walking up from behind twice 	
26. The handler must handle PERSISTENT and INTENSE unwanted interactions appropriately, redirecting the dog's attention and maintaining control whilst the dog is worked off lead.	
INFINATE OF STREET	

27. The handler must deal with access refusals correctly, following any specific guidelines or instructions, even if security refuse entry.	
 28. The dog must demonstrate they can safely go to the loo with the handler at peak time. Any of the following are acceptable: A passive absence of 5 minutes (if held by a friend) Joined in the loo Waiting outside the cubicle with a lead passed under the door. 	
29. The partnership must be able to demonstrate the dog can appropriately interact with at least 12 different novelty objects off lead/DA.	
30. The partnership must show that they can safely work around all of the following off lead/DA (if present):	
 Other people (different ages, heights, ethnicities, clothing types, hi viz, volume, movement types) Other animals (pet dogs, assistance dogs, assistance cats, small animals, wild animals, birds etc) 	

Please note: A 100% score is required to pass the test.
